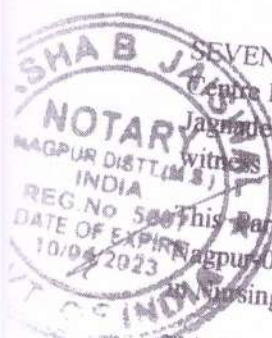

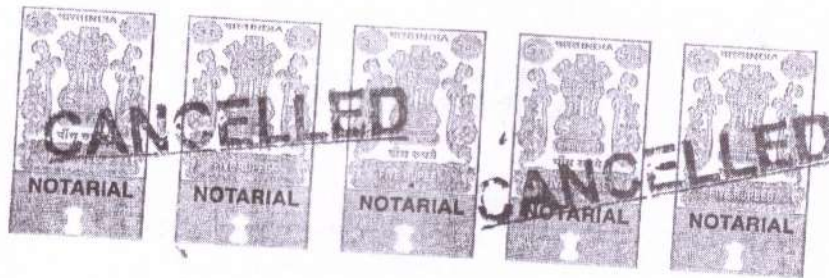

6. The college should ensure compliance to the respective regulatory bodies in terms of Accreditation and other norms as required.
7. The College will provide its Faculty onsite to effectively implement and supervise the clinical Rotation during all hours.
8. The College faculty will be responsible for planning, directing and evaluating the students Learning experience.
9. The College will provide the Hospital with a list of the students who are participating in the Clinical experience program, the unit locations within the hospital where they are assigned.
10. The Hospital will provide physical orientation to the college faculty in lieu of providing an Understanding of the physical set up of the hospital.
11. The College will inform its faculty and students of the hospital's policies and regulations, which relate to the clinical experience program at the hospital.
12. The students will have to abide by the code of conduct.

6) As students will come for clinical experience so hospital will not be liable for any responsibility to the students like any kind of their health, emergency or any kind of claim.

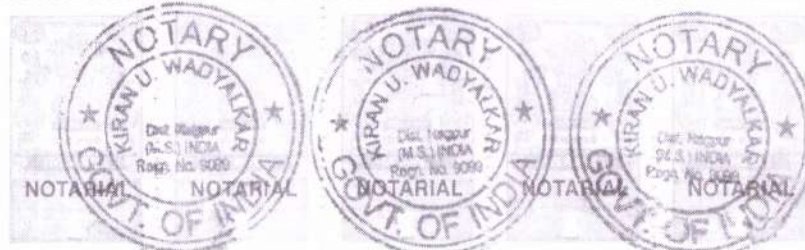

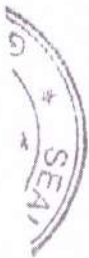
